1. **Monitors Needed for September**

We still need monitors for 13 days in the month of September. Per association rules, we must have monitors on duty during all club sponsored events. Please sign up and help your club. Here are instructions for signing up:

You may sign-up to monitor by going to our website at www.grandpickleball.org and clicking on "Monitor Schedule" in the top menu. In the bottom left corner of the calendar is a link to login. Click on the link. The username is "club" and the password word is "member". The calendar will reappear after signing in. Click on the date you would like to serve and then click on "add event". When you get to the "add event" screen, you only need to fill in your name and complete the start and end time, which is 8:00 am to 10:00 am this time of year, or the same hours as the drop-in event during other times of the year.

2. **NO Pets Allowed on the Pickleball Courts**

As a reminder, all pets within SCG must be on a leash and are not allowed on any sport courts, including the Pickleball courts. If you have a pet, you may use the Pavilion if your pet is on a leash.
